# USS New York Adoption by 9/11 Families' Association



On May 28, 2011 in a ceremony on board the USS New York, the September 11<sup>th</sup> Families' Association adopted the ship to support the education, morale and welfare of the crew.

The Association has been involved with USS New York since she was christened in March 2008. During the commissioning in New York City in 2009, the Association welcomed crew members and their families to the Tribute WTC Visitor Center to share the personal stories of 9/11. Association President Lee lelpi said, "We are honored to continue our relationship with the USS New York by formally adopting the ship to ensure that all crew members understand the significance of the 7.5 tons of World Trade Center steel in the bow stem." Last year in honor of

### September 11<sup>th</sup> as a National Day of Service and Remembrance, the Association hosted family members, survivors, and first responders who assembled care packages for each sailor on the USS New York. Jennifer Adams, CEO of the Association noted after the ceremony, "The average age of sailors on board the ship is 20 years

old. In 2001, they were 10 years old. It is our mission as the September 11<sup>th</sup> community to help them understand the significance and personal history of 9/11. They will be the representatives of America on missions around the world."



During the ceremony, the ship's Chaplain Laura Bender stated, "We belong to New York in a way no other ship and crew belong, for we are a living memorial; we are a tribute in honor and memory; we are a symbol of the strength and resolve of our nation to stand against evil in whatever form it presents itself. No matter what mission lies ahead for USS New York, the covenant we will make with the 9/11 families, survivors, and recovery workers will be our strength."

# **President Visits the WTC Site**

On May 5, 2011, days after the killing of Osama bin Laden, President Barack Obama visited the World Trade Center site. The President visited Engine 54, Ladder 4 in midtown and the First Precinct police station before traveling to World Trade Center site to meet with first responders and lay a wreath.

Following the wreath laying ceremony the President went to the 9/11 Memorial Preview Site where he met with a small group of family members including September 11<sup>th</sup> Families' Association President Lee lelpi who was moved by the visit, "The President spoke to us from the heart—there was no script—and I felt he was very sincere. I took the opportunity to emphasize to him that schools nationwide need to be teaching about the history of 9/11." Planning is underway for the President to visit the World Trade Center site again on the opening of the memorial on September 11, 2011.

On the same day as the President's visit to New York, Vice President Biden laid a wreath of white lilies at the Pentagon Memorial. Defense Secretary Robert Gates and former Defense Secretary Donald Rumsfeld also attended the silent ceremony.

Special Master for the Zadroga Act. By July 8, 2011, the fund must release information on how to apply for the September 11th Victim Compensation Fund, which will be reopened for 5 years. H.R. 847, the James Zadroga 9/11 Health and Compensation Act, provides health care for those exposed to toxins released by the collapse of the World Trade Center towers. The act is a victory for ailing 9/11 first responders and survivors who have waited more than nine years for the federal government to approve a comprehensive plan to deal with the public health disaster caused by the attacks.

The Zadroga Act also provides the World Trade Center Health Program (WTC Program) for medical monitoring and treatment of 9/11-related health conditions. The WTC

Program is set up for emergency personnel, rescue and clean-up workers who responded as well as students attending school and people employed in the area. An initial health evaluation will determine program eligibility, health monitoring and medical care for 9/11 related health conditions at the Centers for Excellence (locations under Resource Column to the left).

### Facts about the James Zadroga 9/11 Health and Compensation Act:

funding for the health program over five years at \$1.5 billion. Reopen the Victim Compensation Fund (VCF) for five years to file claims. Fund the VCF at \$2.8 billion for six years, with \$.8 billion available for payments in the first five years and \$2.0 billion available for payment in year six. Claims will be paid in 2 installments—one payment in the first five years, and a second payment in the sixth year of the program.

# Ashinaga Visits Tribute Center



The Japanese non-profit Ashinaga visited the Tribute Center on June 8, 2011, letting orphans from the March 11<sup>th</sup> earthquake and tsunami meet children who lost parents on September 11<sup>th</sup> and in Hurricane Katrina. "These children are bonded by an unspeakable loss. How do you move forward when the love, support and stability from your parents is suddenly gone? I have great admiration for these children who have taken a big step forward to support one another. It is very similar to the 9/11 community of support we have built here at the Tribute Center." said Lee lelpi after talking to the children.

Ashinaga organized an international summer camp for orphans in Japan from 2000 to 2007, inviting 440 orphans from 79 countries, including children/teenagers who lost a parent on September 11<sup>th</sup>.

# 9/11 Memorial Name Listing

The names of the 2,982 people who lost their lives in the September 11, 2001 and February 26, 1993 attacks have been inscribed into bronze parapets surrounding the Memorial Pools. The Memorial Pools are located in the footprints of the Twin Towers. Every name has a code containing N for North Pool or S for South Pool, followed by a panel number that indicates the location. Kiosks will also be available to look up the location of each name.

The names are categorized into nine groups: North Tower, Flight 11, February 26, 1993 on the North Pool and South Tower, First Responders, Flight 175, Pentagon, Flight 77, and Flight 93 on the South Pool. Within these groups, names are arranged by employee and company affiliation, as well as by additional requests from family members and surviving colleagues for specific names to be inscribed next to one another. This unique design allows the names of family, friends, and colleagues to be memorialized together. The memorial will be dedicated on the tenth anniversary and open for families to visit. Beginning July 6, families will be offered the first opportunity to secure advance reservations to visit the Memorial starting September 12, 2011.

# **World Trade Center Site under Construction**



Construction at the WTC site is progressing quickly. Steel for WTC Tower 1 has risen to the 68th floor. Tower 4 is approximately 27stories, while the foundations for Towers 2, 3 and the Transit Hub are being completed. Almost 50% of the 400 trees on the memorial plaza have been planted, including the Survivor Tree. The museum pavilion structure is complete and both of the waterfalls for the memorial pools are being tested. This tremendous progress is due to the dedication of the Port Authority, Silverstein Properties and the State and City of New York.


